**SUMMARY OF CREDENTIALS AND PROFESSIONAL EXPERIENCE**

After graduating from high school in 1971, Dr. Bunch received a nomination to attend the United States Military Academy at West Point, New York by Senator Allen Ellender and enlisted in the U.S. Army. Following basic training at Fort Polk, Louisiana and West Point preparatory training at USMA Preparatory School at Fort Belvoir, Virginia, he was admitted to the United States Military Academy, West Point, New York, in 1972. The primary focus of education at West Point was engineering. He attended West Point for two years prior to making a decision to seek a healthcare profession. He left West Point Military Academy in good standing ranked in the top 25% of his class in academics and leadership. He made the Dean's list at West Point throughout his sophomore (yearling) year. He served 5 more years in the Army Reserve (inactive).

Following West Point, Richard Bunch attended Louisiana State University (LSU) in Baton Rouge for one year as a junior in a pre-med curriculum and attended LSU Medical Center, Department of Physical Therapy for the next 3 years, graduating in May, 1977. He subsequently became certified by the American Medical Board of Examiners as a licensed physical therapist. After becoming licensed as a physical therapist, he worked one year at East Jefferson Hospital before entering graduate school, Department of Anatomy, at L.S.U. Medical Center in New Orleans, La.

In 1978, Richard Bunch was accepted into the doctoral (Ph.D.) program offered in the Department of Anatomy at LSU School of Medicine to study and perform research in

developmental neurobiology and physiology. As part of his graduate school curriculum Dr. Bunch lectured in various medical school courses to medical students that included Neuroanatomy, Histology, and Human (Gross) Anatomy and Embryology. He was mentored in his doctoral program by his major professor, Dr. C.H. Narayanan, a developmental neurobiologist who was mentored by Dr. Viktor Hamburger, one of the pioneers in developmental neurobiology and who studied under Nobel Prize winner, Dr. Hans Spemann. Dr. Spemann, a German embryologist, received the Nobel Prize in Physiology or Medicine in 1935 for his discovery of embryonic induction using glass microsurgical tools. As an integral part of his medical research, Dr. Bunch performed microsurgical procedures on laboratory animal embryos and fetuses using modernized versions of the glass microsurgical tools developed by Dr. Spemann. After 5 years of graduate studies and medical research in developmental neural control of coordinated motor activity, Richard Bunch published his thesis, *An Analysis of Ontogenetic Events Related to Neural and Behavioral Development Underlying Coordinated Limb Movements* and received his doctorate (Ph.D.) with honors in Neuroanatomy in 1983.

Upon receiving his doctorate, Dr. Bunch was offered both a post-doctoral fellowship at Emory University and a faculty appointment at LSU Medical Center (LSUMC) in the Department of Physical Therapy. Dr. Bunch chose the latter and taught physical therapy and medical school classes. He served on LSUMC's physical therapy faculty for 10 years while maintaining a clinical practice via the faculty income sharing plan, achieving the position of Associate Professor. During his academic tenure, Dr. Bunch created and directed the School of Allied Health Research Committee and Industrial Physical Therapy Clinic. He taught Kinesiology, Neuroanatomy, Patient Evaluation and Management, Introduction to Therapeutic Exercise and Advanced Manual Therapy in the Masters of Health Science courses. He taught clinical correlation lectures in Gross Human Anatomy curriculum for LSUMC medical students and occasionally lectured to medical residents.

In 1993, Dr. Bunch left his full-time academic career at LSU Medical Center to enter private practice. Upon his departure from full-time academics, Dr. Bunch founded Industrial Safety & Rehabilitation (ISR) Institute, Inc. and continues to serve as the owner and CEO of ISR Institute, Inc. ISR Institute, Inc. is a specialty practice that offers ergonomics, training/education, research and wellness consulting.

Dr. Bunch also founded ISR Physical Therapy, LLC, consisting of three physical therapy clinics located in New Orleans (Harahan) and Houma, Louisiana, and served as manager and owner of this practice until 2015. ISR Physical Therapy, LLC offers out-patient orthopedic physical therapy services and functional capacities testing (FCEs).

In 2010, Dr. Bunch founded WorkSaver Employee Functional Testing Systems, LLC and currently serves as Manager and owner of this organization. WorkSaver Employee Functional Testing Systems, LLC provides nation-wide employee functional capacity testing for new hire and return to work cases (post injury or illness) to industries via a certified clinic network using Dr. Bunch's proprietary program called "WorkSaver<sup>sm</sup> Systems". Over the years, Dr. Bunch has conducted numerous job physical demands validations, ergonomic assessments and injury prevention/wellness seminars for power, marine, oil, chemical, manufacturing, coal mining (surface and underground), warehouse, lumber mill, energy, and railroad industries.

In the field of ergonomics, Dr. Bunch was instrumental in developing Chevron's national and international QWE (office ergonomics) program. He provided roll-out QWE training for Chevron throughout the United States, London, England, Cape Town Africa, and Singapore. Dr. Bunch subsequently developed a federally registered proprietary ergonomics certification program that integrates clinical biomechanics and wellness principles with ergonomics (human factors engineering). The training and certification program, Certified Behavioral-Based Ergonomic Specialist (CBES), is five days in duration. Faculty members include a medical physician and physical therapists. This certification is offered to safety professionals, industrial hygienists and occupational health professionals nationally. Dr. Bunch has provided corporate-wide ergonomics training and analyses for numerous companies such as Entergy, Hess, CSX Transportation, Nebraska Public Power Department, Union Pacific Railroad, Georgia-Pacific, Constellation Energy and others. Dr. Bunch has also developed numerous injury prevention and wellness videos for marine, railroad, construction, and oil industries.

Dr. Bunch developed the WorkSaver<sup>sm</sup> functional capacity evaluation (FCE) which has been reviewed by organizations such as LWCC and presented at national medical conferences. He has conducted thousands of FCEs and continues to provide FCEs. He specializes in conducting FCEs on complex medical cases. Dr. Bunch has been accepted as an expert in FCEs both in Federal and State Courts and has published a medical book chapter entitled, AMA Guide to Functional Capacities Evaluations.

Dr. Bunch has maintained his consulting practice in ergonomics but retired from his clinical practice as a physical therapist on January 1, 2023. Dr. Bunch currently serves as an Adjunct Associate Professor at the Tulane University School of Public Health and Tropical Medicine, Department of Global Environmental Health Sciences, where he lectures each year on office and field ergonomics. He has published book chapters on functional capacities evaluations, ergonomics, back injury prevention and stress management and has presented national seminars and keynotes on these topics as well as injury prevention and wellness interventions for numerous safety and health conferences.

Dr. Bunch is currently performing ergonomics assessments as a consultant and provides professional lectures on ergonomics and wellness. He is currently under contract by Wiley and Sons, an international publishing organization, to write a book addressing physical abilities testing and ergonomics for job placement and return to work cases in compliance with federal and state antidiscrimination laws.
